HO-CHUNK NATION LEGISLATURE PER CAPITA DECLARATION FOR MAY 1, 2011 RESOLUTION 04-05-11 E

WHEREAS, on November 1, 1994, the Secretary of the Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Tribe; and

WHEREAS, the Ho-Chunk Nation ("Nation") is a federally recognized Indian Tribe, organized pursuant to the Indian Reorganization Act of 1934; and

WHEREAS, Article V, Section 2(a) of the Ho-Chunk Nation Constitution ("Constitution") grants the Ho-Chunk Nation Legislature the power to make laws, including codes, ordinances, resolutions, and statutes; and

WHEREAS, Article V, Section 2(d) of the Constitution grants the Legislature the power to authorize expenditures by law and appropriate funds to the various Departments of the Nation in an annual budget; and

WHEREAS, Article V, Section 2 (s) of the Constitution grants the Legislature the power to promote public health, education, charity, and such other services as may contribute to the social advancement of the members of the Ho-Chunk Nation; and

WHEREAS, the Per Capita Distribution Ordinance (2 HHC 12) provides for per capita distribution of revenues appropriated by the Legislature from gaming revenues.

NOW THEREFORE BE IT RESOLVED that the Legislature, pursuant to its constitutional authority, does hereby declare that a per capita distribution will be made to Tribal members in accordance with the Nations Per Capita Distribution Ordinance(2 HHC 12) on May 1, 2011 in the amount of \$3,000.00 per tribal member (7,196 eligible members) for a total distribution of \$21,588,000.00

CERTIFICATION
