**HO-CHUNK NATION LEGISLATURE
AUTHORIZES TWO REPRESENTATIVES FROM THE
HO-CHUNK NATION LEGISLATIVE BRANCH
FOR BUSINESS CREDIT CARD VENDOR – ELAN FINANCIAL SERVICES
RESOLUTION 11-3-10 I**

WHEREAS, On November 1, 1994, the Secretary of the Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Business Committee; and

WHEREAS, the Ho-Chunk Nation (“Nation”) is a federally recognized Indian Tribe, organized pursuant to the Indian Reorganization Act of 1934; and

WHEREAS, the Legislature of the Ho-Chunk Nation is the duly constituted governing body of the Ho-Chunk Nation (“Legislature”) pursuant to the Constitution of the Ho-Chunk Nation; and

WHEREAS, Article V, Section 2 (a) enables the Nation, through the Legislature, to make laws, including codes, ordinances, resolutions, and statutes; and

WHEREAS, Article V, Section 2 (f) enables the Nation, through the Legislature, to set the salaries, terms, conditions of employment for all governmental personnel; and

WHEREAS, the Ho-Chunk Nation Legislature adopted the Credit Card Usage Policy for elected officials and employees by resolution on February 16, 1999; and

WHEREAS, it is in the best interest of the Nation to designate the Legislative Budget Analyst and the Presiding Officer of the Ho-Chunk Nation Finance Committee to be the Nation’s authorized representative to make modifications to existing cardholder account(s), change credit limits, and add new cardholders for the Ho-Chunk Nation;

NOW THEREFORE BE IT RESOLVED that the Ho-Chunk Nation Legislature hereby delegates authority to Legislative Budget Analyst and Presiding Officer of 36Ho-Chunk Nation Finance Committee to be authorized representative(s) for the Ho-Chunk Nation Legislature for the Ho-Chunk Nation Business Credit Card vendor – Elan Financial Services.


