### HO-CHUNK NATION LEGISLATURE TRANSPORTATION IMPROVEMENT PLAN RESOLUTION 3-03-09 C


- WHEREAS,** on November 1, 1994, the United States Secretary of Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Tribe, and
- WHEREAS,** the Ho-Chunk Nation ("Nation") is a federally recognized Indian Tribe, organized pursuant to the Indian Reorganization Act of 1934; and
- WHEREAS,** Article V, Section 2 (a) of the Ho-Chunk Nation Constitution ("Constitution") grants the Ho-Chunk Nation Legislature ("Legislature") the power to make laws, including codes, ordinances, resolutions, and statutes, and
- WHEREAS,** Article V, Section 2, (i) of the Constitution authorizes the Legislature to negotiate and enter into treaties, compacts, contracts, and agreement with other governments, organizations, or individual; and
- WHEREAS,** the Ho-Chunk Nation recognizes adequate and safe road infrastructure is critical to all Tribal development; and
- WEHREAS,** the Bureau of Indian Affairs shares responsibility for developing and maintaining roads on Indian lands; and
- WHEREAS,** the Ho-Chunk Nation wishes to update it's Transportation Improvement Plan to address the critical need for expanded and improved road infrastructure for a rapidly developing Tribal community.

**NOW THEREFORE BE IT RESOLVED,** that the Ho-Chunk Nation Legislature, pursuant to its Constitutional authority hereby requests the Bureau of Indian Affairs to update the roads listed in the attachment to the Ho-Chunk nation Transportation Improvement Plan.

**BE IT FURTHER RESOLVED,** that the following names of roads/properties are attached to this resolution as Attachment A and are to be included in the update of the Transportation Improvement Plan.

#### CERTIFICATION
