

BUDGET MODIFICATION
RESOLUTION 7-07-09 H**


- WHEREAS,** on November 1, 1994, the United States Secretary of the Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Tribe; and
- WHEREAS,** the Ho-Chunk Nation ("Nation") is a federally recognized Indian Tribe, pursuant to the Indian Reorganization Act of 1934; and
- WHEREAS,** Article V, Section 2(a) of the Ho-Chunk Nation Constitution ("Constitution") gives the Ho-Chunk Nation Legislature ("Legislature") the power to make laws, including codes, ordinances, resolutions, and statutes; and
- WHEREAS,** Article V, Section 2(b) of the Constitution grants the Legislature the power to establish Executive Departments, and to delegate legislative powers to the Executive branch to be administered by such Departments, in accordance with the law; any Department established by the Legislature shall be administered by the Executive; the Legislature reserves the power to review any action taken by virtue of such delegated power; and
- WHEREAS,** Article V, Section 2(d) of the Constitution grants the Legislature to authorize expenditures by law and appropriate funds to the various Departments in an annual budget; and
- WHEREAS,** due to the year-end closure of FY 08-09 and a change in vendor a budget modification is required to move funds into the appropriate line items(s) to cover the overages that have occurred in other line items.

NOW THEREFORE BE IT RESOLVED, that the Ho-Chunk Nation Legislature approves the budget modification # 01/9000-06-09-M03 in the amount of \$ 3,180.00 from the Signage line item and move into the Maintenance Supplies line item; \$11,900.00 from the Security Officer line item and move into the Security Systems line item; \$2,500.00 from the Facility Specialist line item and move into the Day Care Equipment line item; \$52,000.00 from the Lifeguard line item and move into the Major Renovation line item. Modification #01/2172-06-09 D01; decreasing the Mail Clerk Line item by \$18,500.00; decreasing the Supervisor line item by \$3,000.00; decreasing the Benefits line item by \$1,500.00 and moving the total of \$23,000.00 into the General Fund. This will then be moved from the General Fund into Budget Modification #01/9000-06-I01 into the Major Renovations line item.

CERTIFICATION

I, the undersigned, as Tribal Secretary of Ho-Chunk Nation, hereby certifies that the Legislature of the Ho-Chunk Nation, composed of 13 members of whom 13 constituting a quorum were present at a meeting duly called and convened and held that on the 7th day of July, 2009, that the foregoing resolution was adopted at said meeting by an affirmative vote of 12 members, 0 opposed, and 1 abstaining, pursuant to the Article V, Section 2(a) and (x) of the Constitution of the Ho-Chunk Nation approved by the Secretary of the Interior on November 1, 1994, and that the foregoing resolution has not been rescinded or amended in any way. I further certify that this is a verified copy of said resolution.
