**HO-CHUNK NATION LEGISLATURE**  
**LAND LEASE RAE ANNA GARCIA**  
**RESOLUTION 3-19-08 D**

- WHEREAS,** on November 1, 1994, the United States Secretary of the Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Tribe; and
- WHEREAS,** the Ho-Chunk Nation ("Nation") is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1934; and
- WHEREAS,** Article V, Section 2 (a) of the Ho-Chunk Nation Constitution ("Constitution") grants the Ho-Chunk Nation Legislature ("Legislature") the power to make laws, including codes, ordinances, resolutions, and statutes; and
- WHEREAS,** Article V, Section 2 (i) of the Constitution grants the Legislature the power to negotiate agreements with other governments, organizations, or individuals; and
- WHEREAS,** Article V, Section 2 (l) of the Constitution grants the Legislature the power to enact laws to manage, lease, permit, or otherwise deal with the Nation's lands, interests in lands or other assets; and
- WHEREAS,** the Nation does hold 100% interest in the property known as Lot # 15, East Sandpillow Subdivision Located in the NW¼ of the NW¼ and the NE¼ of the NW¼ of Sec. 4, T21N, R3W, Town of Brockway, Jackson County, Wisconsin; and
- WHEREAS,** the Lessee(s) shall have and hold the parcel for a term of twenty-five (25) years, with the option to renew for an additional twenty-five (25) years; and


**NOW THEREFORE BE IT RESOLVED,** that the Ho-Chunk Nation Legislature hereby grants a lease to Rae Anna Garcia and said lease is located, and being more particularly describe as follows:

Lot # 15, East Sandpillow Subdivision Located in the NW¼ of the NW¼ and the NE¼ of the NW¼, Sec. 4, T21N, R3W, Town of Brockway, Jackson County, Wisconsin containing 32,398.30 SQ. FT. or 0.74 acres more or less.

**BE IT FURTHER RESOLVED,** that Rae Anna Garcia will abide by all guidelines established by the Department of Housing – Home Ownership Program.

**CERTIFICATION**

I, the undersigned, as Tribal Secretary for the Ho-Chunk Nation, hereby certify that the Legislature of the Ho-Chunk Nation, composed of **11 members**, of whom **7** constituting a quorum were present at a meeting duly called and convened and held on the **19<sup>th</sup> day of March, 2008**, that the foregoing resolution was adopted at said meeting by an affirmative vote of **6 members, 0 opposed, and 1 abstaining**, pursuant to the authority of Article V, Section 2(a) and (x) of the Constitution of the Ho-Chunk Nation approved by the Secretary of the Interior on November 1, 1994, and that said resolution has not been rescinded or amended in any way.
