HO-CHUNK NATION LEGISLATURE RESCISSION OF RESOLUTION 2-26-08 A MORATORIUM ON REVISIONS TO CERTAIN JOB DESCRIPTIONS RESOLUTION 4-29-08 A

- WHEREAS,** on November 1, 1994, the United States Secretary of the Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Tribe; and
- WHEREAS,** the Ho-Chunk Nation ("Nation") is a federally recognized Indian Tribe, organized pursuant to the Indian Reorganization Act of 1934; and
- WHEREAS,** Article V, Section 2(a) of the Ho-Chunk Nation Constitution ("Constitution") grants the Ho-Chunk Nation Legislature ("Legislature") the power to make laws, including codes, ordinances, resolutions, and statutes; and
- WHEREAS,** Article V, Section 2(b) of the Constitution grants the Legislature the power to establish Executive Departments, and to delegate legislative powers to the Executive branch to be administered by such Departments, in accordance with the law; any Department established by the Legislature shall be administered by the Executive; the Legislature reserves the power to review any action taken by virtue of such delegated power; and
- WHEREAS,** Article V, Section 2(d) of the Constitution grants the Legislature to authorize expenditures by law and appropriate funds to the various Departments in an annual budget; and
- WHEREAS,** Article V, Section 2(f) of the Constitution grants the Legislature the power to set the salaries, terms and conditions of employment for all governmental personnel; and
- WHEREAS,** Article V, Section 2(i) of the Constitution grants the Legislature the power to negotiate and enter into treaties, compacts, contracts, and agreements with other governments, organizations, or individuals; and
- WHEREAS,** Article V, Section 2(x) of the Constitution grants the Legislature the power to enact any other laws, ordinances, resolutions, and statutes necessary to exercise its legislative powers delegated by the General Council pursuant to Article III including but not limited to the foregoing list of powers; and
- WHEREAS,** the Legislature passed Resolution 2-26-08 A, entitled "Moratorium on Revisions to Certain Job Descriptions."; and
- WHEREAS,** Resolution 2-26-08 A placed a moratorium on revising the salary ranges of job descriptions; and
- WHEREAS,** The moratorium was until such time as the Legislature approves revised salary ranges for individual Governmental Branches, Executive Departments, and enterprises of the Ho-Chunk Nation; and
- WHEREAS,** Resolution 2-26-08 A instructed the Department of Personnel to provide the Legislature with revised salary ranges for individual Governmental Branches, Executive Departments, and enterprises of the Ho-Chunk Nation; and
