GRANTING CONSENT AS AN INTEREST HOLDER
TO THE HEAS TCHOT A WAU HE KAH HOMESTEAD,
TRACT NUMBER 441-207 FOR A BIA RESIDENTIAL LEASE
FOR ANTOINETTE THAYER
RESOLUTION 7-08-08 E**

- WHEREAS,** on November 1, 1994, the United States Secretary of the Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Tribe; and
- WHEREAS,** the Ho-Chunk Nation ("Nation") is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1934; and
- WHEREAS,** Article V, Section 2 (a) of the Ho-Chunk Nation Constitution ("Constitution") grants the Legislature the power to make laws, including codes, ordinances, resolutions, and statutes; and
- WHEREAS,** Article V, Section 2 (i) of the Constitution grants the Legislature the power to negotiate agreements with other governments, organizations, or individuals; and
- WHEREAS,** Article V, Section 2 (l) of the Constitution grants the Legislature the power to enact laws to manage, lease, permit, or otherwise deal with the Nation's lands, interests in lands or other assets; and
- WHEREAS,** the Nation does hold interest acquired through (ILCP) Indian Land Consolidation Program in the property known as **HEAS TCHOT A WAU HE KAH HOMESTEAD # 441-207** located within **part of the SE ¼ of the NW ¼, Sec. 32 T22N,R3W, 4th P.M. Town of Komensky, Jackson County, WI** containing 40 acres more or less; and
- WHEREAS,** the Nation is being requested to give consent for a residential lease on this property, which shall consist of one parcel, 1-2 acres, more or less, and not more than one dwelling to be authorized on said parcel. Easements for access and utility purposes shall be authorized. A driveway for access may be approved (not to exceed 20 feet in width); and
- WHEREAS,** the Lessee(s) shall have and hold the parcel for a term of twenty-five (25) years, with an automatic renew for an additional twenty-five (25) years; and
- WHEREAS,** the Nation authorizes the United States Secretary of the Interior to grant the lease with payment of rent or other compensation waived; and

NOW THEREFORE, BE IT RESOLVED that the Ho-Chunk Nation Legislature is hereby granting its conditional consent for the entire portion of the Ho-Chunk Nations purchased heirship interest to the Bureau of Indian Affairs for the purpose of issuing a 1-2 acre residential lease on the **HEAS TCHOT A WAU HE KAH HOMESTEAD # 441-207** to **ANTOINETTE THAYER**.

BE IT FURTHER RESOLVED that the Ho-Chunk Nation Legislature only provides its consent on the condition that the exact property description of the 1-2 acre parcel granted to **ANTOINETTE THAYER** be provided to the Ho-Chunk Nation Register of Deeds Office for record keeping and informational purposes; and

BE IT FURTHER RESOLVED that **ANTOINETTE THAYER** will abide by all guidelines established by the Ho-Chunk Nation Department of Housing.
