Petitioner seeks the issuance of a *Writ of Mandamus* from the Supreme Court of the Ho-Chunk Nation. This Court has the authority, pursuant to *HCN R. App. P. Rule 1* to look to Ho-Chunk customs and traditions and the *Federal Rules of Appellate Procedure* for guidance in applying and supplementing these rules. On January 29, 2005 the full Supreme Court reviewed the *Petition for Writ of Mandamus, Appendix* and the *Certificate of Service*. This Court will look to *Federal Rules of Appellate Procedure 21* in this matter. This Court has determined that it is in the interests of justice that this matter is accepted for expedited consideration as is provided for pursuant to *HCN R. App. P. Rule 9(b)* and the following *Scheduling Order* is set:

Chief Trial Judge William Bossman is invited to prepare a *Response to the Petition* by Tuesday, February 8, 2004. Such *Response* is to be filed with the Clerk of the Ho-Chunk Nation Supreme Court by the close of business on that date.

The Ho-Chunk Nation Department of Justice is invited to participate as *Amicus Curiae* and brief the issues raised in the *Petition*. The requested *Brief* is due to be filed in the HCN Supreme Court by the close of business on February 8, 2005.

The Petitioner is requested to file a *Brief* which shall be due on February 8, 2005.


All future filings and correspondence regarding this matter shall be captioned as follows: In re Casimir T. Ostrowski, SU 05-01.

All parties and invitees must provide proof of service on all interested parties.






