

On January 21, 2002, the Appellants, by and through their counsel, Michael Murphy filed an Interlocutory Appeal of the January 9, 2002 ORDER (Determination of Judicial Deference) issued by the

Honorable Todd R. Matha. William F. Gardner, Counsel for the Appellees, filed a response opposing the Appeal on January 31, 2002.

This Court determined that the Trial Court is within its authority to extend the discovery period to bring forth further facts to render a final judgement in this case. See *Michele M. Ferguson v. HCN Insurance Review Commission/Division of Risk Management* SU00-13 (HCN S. Ct., October 14, 2000).

In addition, this Court does not require parties to file a Notice of Appeal simply to preserve an appeal if they plead the application of *HCN R. Civ. P Rule 58(B)* when filing the final appeal. See *Chloris Lowe Jr., Stewart J. Miller vs. HCN Legislative members, et al;* and the *HCN Election Board* SU01-05 (HCN S. Ct., May 4, 2001).



Based on the above, the Appellants' Appeal is hereby **denied**.




