This matter came before the Ho-Chunk Nation Supreme Court Saturday, January 22, 2000 on the Appellants' Affidavit & Order Waiving Payment of Filing Fees and Costs and Motion to Stay the Judgement, both filed on Wednesday, January 19, 2000. Pursuant to HCN Rules of Appellate Procedure, Rule 8 b, this Court is granting waiver of payment of the filing fee and cost. The Court is granting the Motion to Stay, according to appellant Rule 7 c, the lower court ruling in the Eviction Order (Restitution and Relief) and the Writ of Restitution, which were both filed on January 12, 2000. The stay is granted for the sole purpose of allowing the parties to remain within the status quo and to prevent any potential manifest injustice. The Court is ordering the stay during the time of review of the pleadings to determine whether or not the appeal will be accepted. Thus, the Court will allow time as required by the Rules of Appellate Procedure for the opposing party to respond to the Appellants' Notice of Appeal.

This Court hereby Orders:

1. That in accordance with HCN Rules of Appellate Procedure, Rule 8 b. the waiver of the filing fee and costs are **GRANTED**;
2. That the Eviction Order (Restitution and Relief) and the Writ of Restitution filed on January 12, 2000 are **STAYED**;
3. That the Stay of the lower court orders is only until such time as this Court determines whether or not to accept the appeal;
