11 Court may exercise personal jurisdiction over the petitioner and/or respondent due to satisfaction  
12 of one or more of the following conditions (check all that apply):

13  the petitioner is an enrolled member of the Ho-Chunk Nation, and has maintained  
14 a residence in the State of Wisconsin for at least six (6) consecutive months prior to the filing of  
15 this petition;

16  the respondent is an enrolled member of the Ho-Chunk Nation, and has maintained  
17 a residence in the State of Wisconsin for at least six (6) consecutive months prior to the filing of  
18 this petition;

19  the petitioner presently resides on tribal land, and has maintained this residence for  
20 at least six (6) consecutive months;

21  the respondent presently resides on tribal land, and has maintained this residence  
22 for at least six (6) consecutive months;

23  the marriage between the petitioner and respondent was solemnized by a member  
24 of the Ho-Chunk Nation Judiciary.

25 **REQUIRED INFORMATION:** As required by the DIVORCE AND CUSTODY ORDINANCE,

22 **PROHIBITED ACTS:** During the pendency of the action, the parties are prohibited from,  
23 and may be held in contempt of court for any of the following:

24 1) harassing, intimidating, physically abusing or imposing any restraint on the person or  
25 liberty of the other party or a minor child of either party; or

26 2) without the consent of the other party or an order from the Court, encumbering,  
27 concealing, damaging, destroying, transferring, or otherwise disposing of property owned by either  
28 or both of the parties, except in the usual course of business, in order to secure necessities or in  
order to pay reasonable costs and expenses of the action, including attorney fees;

3) Without the consent of the other party or an order of the Court, establishing a residence  
with a minor child of the parties outside the state of Wisconsin or more than 150 miles from the  
residence of the other party within the state.

1           4) Removing a minor child of the parties from the state of Wisconsin without consent of  
2 custodial parent.

3           **ATTACHMENTS:** The petitioner must attach any written agreement between the parties  
4 as to maintenance of either party, division of debts and assets, or support, legal custody and  
5 physical placement of the children. If the petitioner is requesting that the Court grant child support,  
6 spousal maintenance or division of debts and assets acquired during the marriage, and the parties  
7 have not entered into a written agreement as to such requests, the petitioner must attach a  
8 completed *Statement of Income, Assets, Debts & Living Expenses*. Likewise, the respondent must  
9 attach a completed copy of the *Statement of Income, Assets, Debts & Living Expenses* if stipulating  
10 to the above requests and assertions as evidenced by the joint filing of this pleading.

21 kind. I understand that any decision reached by the Ho-Chunk Nation Trial Court is binding and  
22 that if I disagree with the findings or conclusions or remedies of the Trial Court, I may file an  
23 appeal with the Ho-Chunk Nation Supreme Court. I further acknowledge that since I am  
24 submitting myself to the jurisdiction of the Ho-Chunk Nation Judiciary, I am subject to its  
25 determinations, including those relating to contempt of court.
