RESCISSION AND RESTATEMENT OF RESOLUTION 04-03-24E TIMELINE AND PROCEDURES FOR LEGISLATIVE REDISTRICTING

RESOLUTION 05-21-24 R

- WHEREAS, on November 1, 1994, the United States Secretary of the Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Tribe; and
- WHEREAS, the Ho-Chunk Nation ("Nation") is a federally recognized Indian Tribe, pursuant to the Indian Reorganization Act of 1934; and
- WHEREAS, Article V, Section 2(a) of the Ho-Chunk Nation Constitution ("Constitution") gives the Ho-Chunk Nation Legislature ("Legislature") the power to make laws, including codes, ordinances, resolutions, and statutes; and
- WHEREAS, Article V, Section 2(f) of the Constitution grants the Legislature the power to set the salaries, terms and conditions of employment for all governmental personnel; and
- WHEREAS, Article V, Section 2(r) of the Constitution grants the Legislature the power to protect and foster Ho-Chunk religious freedom, culture, language, and traditions; and
- WHEREAS, Article V, Section 2(x) of the Constitution grants the Legislature the power to enact any other laws, ordinances, resolutions, and statutes necessary to exercise its legislative powers delegated by the General Council pursuant to Article III including but not limited to the foregoing list of powers; and
- WHEREAS, Article V, Section 4 of Constitution provides:

Section 4. Redistricting or Reapportionment.

The Legislature shall have the power to redistrict or reapportion including changing, establishing, or discontinuing Districts. The Legislature shall maintain an accurate census for the purposes of redistricting or reapportionment. The Legislature shall redistrict and reapportion at least once every ten (10) years

beginning in 1995, in pursuit of one-person/one-vote representation. The Legislature shall exercise this power only by submitting a final proposal to the vote of the People by Special Election which shall be binding and which shall not be reversible by the General Council. Any redistricting or reapportionment shall be completed at least six (6) months prior to the next election, and notice shall be provided to the voters; and

- WHEREAS, the last Redistricting of Legislative Districts was completed on October 12, 2018, when the voters of the Ho-Chunk Nation selected a new scenario through a Special Election conducted by the Ho-Chunk Nation Election Board; and
- WHEREAS, in recognition that Article V, Section 4 of the Constitution requires the completion of redistricting at least once every ten years, the Legislature has started the process of redistricting, with the goal of selecting a final proposal, conducting a Special Election, and completing the process at least six (6) months prior to the Nation's General Election in June of 2025; and
- WHEREAS, the Legislature adopted Resolution 11-07-17A, establishing a Legislative Workgroup on Redistricting, as is authorized under the Legislative Organization Act (for Workgroups); and
- WHEREAS, Section 20.c of the Ho-Chunk Nation Election Code (codified at 2 HCC §6) sets forth certain procedures when the Legislature carries out Redistricting pursuant to Article V, Section 4 of the Constitution; and
- WHEREAS, Section 20.c(1)(a) of the Ho-Chunk Nation Election Code ("Election Code") addresses tribal census requirements and states that "[t]he Ho- Chunk Nation Office of Tribal Enrollment will keep an accurate census of all Tribal Members who are eligible to vote. If the Legislature determines to have the Election Board conduct a Special Election for Redistricting, the Legislature or its designee will obtain from the Office of Tribal Enrollment an accurate census of all Tribal Members who are eligible to vote"; and
- WHEREAS, Section 20.c(1)(c) of the Election Code states that "[t]he Legislature shall pass a Resolution determining the date that the Ho-Chunk Nation Office of Tribal Enrollment shall use for determining the census for purposes of the Special Election for Redistricting"; and
- WHEREAS, general guidelines and a formula for Redistricting have been shared by Legislators at the District-Area meetings, and notification provided that the Legislature is starting the process; and

- WHEREAS, an article was published in the tribal newspaper, the *Hocak Worak*, on November 10, 2023, providing information to tribal membership about the redistricting process; and
- WHEREAS, Legislators of the Nation have also informed tribal members attending District-Area meetings that they may submit proposed Redistricting scenarios with new District boundaries to the Legislative Office in Black River Falls, Wisconsin; and
- WHEREAS, during the last legislative redistricting in 2018, the Legislature adopted Resolution 2-23-18E, setting forth timelines and procedures for the Legislature, Nation, and tribal members to follow, leading up to a Special Redistricting Election in October 2018; and
- WHEREAS, similar to 2018, the Legislature found it appropriate and necessary to establish a general timeline and procedures to continue the Redistricting process, in order to keep tribal membership informed and allow for the greatest amount of participation by Ho-Chunk Tribal Members in this important process; and
- WHEREAS, the Legislature adopted Resolution 04-03-24E, which updated and revised the Timeline and Procedures for Legislative Redistricting, by rescinding and restating Resolution 02-20-24M, resulting in more time for tribal members to consider the formulation of proposals to the Legislature for updated redistricting scenarios; and
- WHEREAS, in light of the fact that the deadline to submit redistricting scenarios has passed, and the Legislative Forum on Redistricting has taken place, the Legislature has determined to give tribal members more time to review submitted scenarios, thus requiring an update to Resolution 04-03-24E; and
- WHEREAS, accordingly, the Legislature finds it appropriate to rescind and restate Resolution 04-03-24E; and
- NOW THEREFORE, BE IT RESOLVED that the Legislature, pursuant to its Constitutional authority, creates the following general timeline and procedures for conducting the Redistricting Process:
 - (1) The Ho-Chunk Nation Office of Tribal Enrollment shall provide to the Legislature and Legislative Counsel's Office a current census of all adult Ho-Chunk Members in each Wisconsin county, every state outside of Wisconsin and Ho-Chunk Members outside of the United States, updated as of March 5, 2024;

- (2) Tribal Members shall have until the date of April 26, 2024, by 4:30 p.m. Central time, to submit any proposed Redistricting scenarios they wish to suggest, including a description of their scenario(s); submitted by email to Redistricting@ho-chunk.com, or by hard copy provided at the Legislative Office within the Tribal Office Building (T.O.B.) of the Nation in Black River Falls, Wisconsin; any such proposal(s) should include the name and contact information for the Tribal Member;
- (3) The Legislature will schedule a meeting, hearing or other forum in person or virtually on, or around, May 9, 2024 for Tribal Members to explain and discuss any proposed Redistricting scenario they have submitted;
- (4) Next, the Legislative Workgroup on Redistricting may review proposed scenarios, and the Legislature will consider proposed redistricting scenarios at Regular or Special Meetings, in order to approve a final redistricting proposal by the end of July 2024;
- (5) Shortly after approval of the final redistricting proposal, an article will be published in the *Hocak Worak*, in a regular or special edition, in order to ensure Ho-Chunk Nation Members are aware that the Legislature selected a final proposal, and that the final proposal will be presented to the Nation's Election Board in order to conduct a Special Election on Redistricting; such information shall also be posted on the Nation's website;
- (6) The Legislature, at one of its September 2024 sessions or at a Special Session near such date, will submit the final proposal including the Redistricting Scenario(s) selected by the Legislature to the Election Board;
- (7) As soon as possible after the aforementioned Legislative Session, the *Hocak Worak* shall run a Special Edition providing all necessary information with respect to the Special Election on Redistricting;
- (8) The Election Board shall conduct the Redistricting Special Election no later than October 26, 2024; and

BE IT FURTHER RESOLVED that the dates and timelines above are not the exclusive dates upon which the Legislature, or Legislative Workgroup, may take action with respect to the Redistricting process, and that the events above shall not be the exclusive means by which the Legislature may go through the Redistricting process;

BE IT FURTHER RESOLVED, that the Legislative Counsel's Office shall periodically provide information to the Information Technology Division of the Ho-Chunk Nation to update the Ho-Chunk Nation website with respect to all Redistricting matters as developments warrant, as determined by the Vice-President.

BE IT FURTHER RESOLVED that the Legislature shall include within its budget for fiscal year 2024-2025 such funds as are necessary for the Legislature to accomplish the procedures outlined within this Resolution that occur within fiscal year 2024-2025.

BE IT FURTHER RESOLVED that the Department of Justice shall include in the Election Board's section of the Department of Justice's budget proposal for fiscal year 2024-2025 funding for the Election Board to conduct the Redistricting Special Election.

BE IT FURTHER RESOLVED that the Department of Administration shall include in the *Hocak Worak's* section of the Department of Administration's budget proposal for fiscal year 2024-2025 for the *Hocak Worak* to run a Special Edition of the *Hocak Worak* regarding the Redistricting Special Election.
