scenario was for \$150. Vice President Danielle DeLong agreed to sponsor our Agenda Item Request. These were brought forth to the Legislature for consideration, and on Tuesday July 23, 2024. The Legislature approved Resolution 07.23.24H for the amount of \$150.00 with language that included the following:

***BE IT FURTHER RESOLVED** that adult tribal members who attend and register at the September 21, 2024 Annual General Council meeting will receive the payout, even if quorum is not attained.*

Again, the amount is \$150 per adult tribal member who is in attendance.
